

All cases were the result of investigations conducted by the Adirondack Drug Task Force which consists of the Plattsburgh City Police Department, U.S. Drug Enforcement Administration, U.S. Border Patrol, New York State Police and the Clinton County Sheriff's Department, and the New York State Police Troop B Narcotics Enforcement Unit in conjunction with the Clinton County District Attorney's Office.

There are ten indictments on nine individuals which remain sealed until the named defendants are arrested.

All of these Clinton county indictments are being prosecuted by district attorney Andrew Wylie and assistant district attorney Douglas Collyer.
