The Arizona State Grand Jury accuses **DEBORAH ANN COONEY**, charging on this 7th
day of February, 2022, that in or from Maricopa County, Arizona:

COUNT 1

FRAUDULENT SCHEMES AND ARTIFICES

On or between July 1, 2019 and January 9, 2021, **DEBORAH ANN COONEY**, pursuant to a scheme or an artifice to defraud, knowingly obtained a benefit (to wit: financial benefit) by means of false or fraudulent pretenses, misrepresentations, promises or material omissions, in violation of A.R.S. §§13-2310, 13-2301, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702 and 13-801.

COUNT 2

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about April 1, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 3

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about April 8, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 4

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about April 8, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 5

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about May 26, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 6

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about May 28, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 7

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about May 28, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 8

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about June 17, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 9

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about July 10, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 10

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about September 3, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 11

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about September 30, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 12

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about October 8, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 13

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about November 5, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S.

§§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

COUNT 14

ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about December 3, 2020, **DEBORAH ANN COONEY** knowingly administered a narcotic drug (to wit: "OXYCODONE") to another person, in violation of A.R.S.

§§13-3408(A)(5), 13-3401, 13-701, 13-702, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.
